What happened at the AGM?

Everything was against us this year and, unsurprisingly, the attendance was very disappointing.

Many Owners were put off, citing various reasons: advice in the news against any travel; the weather forecast with threat of snow; the World Cup football; the possible effect of train strikes and weather restricting services; predicted road closures, proximity to Christmas and the lack of any significant issues on the agenda. Four other resort AGMs held over the same weekend, all much bigger than Las Casitas, also suffered a reduced attendance.

It was not helped by the choice of location in the centre of Birmingham city and the £30 cost of parking. A suggestion that we hold an online meeting would not unfortunately meet our legal obligation for an AGM. WimPen agreed to find a new and better venue next time. Let me know if you have any suggestions.

One owner arrived with 25 proxy votes which were all against every proposal. She also held 14 discretionary votes, as well as her own, some of which were mostly used in the same way. I was subsequently told these were a 'protest' vote. We were very surprised, and never found out exactly what these owners were protesting about.

Of course, any owner is perfectly entitled to use their votes as they wish, but it would have been useful to understand exactly what the protest was about so that WimPen or I could attempt to deal with their concerns.

Nevertheless, we had 461 or 19.2% of all possible votes in the room or by proxy and all resolutions were passed.
